## Peace and Justice for all

Members of the Erie pro-life community had an important opportunity to speak up for peace, justice, and proper priorities on March 26, when a Catholic nun, best known for a politically-driven bus tour called "Nuns on the Bus," was in Erie to get an award from Mercyhurst University and speak about peace and justice. The nun's name was Sister Simone Campbell.

Sr. Campbell is the director of a left-leaning organization of politically-active nuns called Network, which lobbies for larger government social welfare programs and backs pro-abortion politicians, even ones as extreme as President Obama.

Sr. Campbell conducted one of her bus tours in the middle of the 2012 presidential campaign, to attack a Republican budget proposal and denigrate its author, U.S. Rep. Paul Ryan of Wisconsin.

A few months later Sr. Campbell was singing the praises of President Obama at the Democratic National Convention, where she was invited to deliver a speech.

The presidential campaign, you will recall, featured a Republican ticket of Governor Mitt Romney and Congressman Paul Ryan, both strong supporters of legal protection for unborn children, and a Democratic ticket of President Barack Obama and Vice-president Joe Biden, both strong supporters of abortion on demand and taxpayer-funding for abortion.

During the Democratic Convention, a

reporter from *National Review* asked Sr. Campbell about the crime of abortion: Should abortion be legal? Her response: "That's beyond my pay grade. I don't know."

Fifty people were delighted to gather at the Mercyhurst main entrance in 20-degree weather to offer a different answer: Babies deserve to be legally protected, not legally killed! Protect every child! "Peace and justice" should not have to wait until birth or any other arbitrary point in a human lifespan. We described the gathering as a "Demonstration of Solidarity with Unborn Children and Their Mothers." One person, 6th District state Rep. Brad Roae, came all the way from Meadville to participate. Ed Franz, a candidate for state representative in the 17th District who lives near Conneautville, also took part.

Sr. Campbell's stated lack of conviction about peace and justice for all, helps account for her lack of discernment about the *Affordable Care Act* (Obamacare), which channels huge amounts of federal money (an estimated \$5 billion this year alone) into insurance plans that pay for abortion on demand, reversing a policy that had been in effect for more than 30 years. (Sr. Campbell publicly denies that this funding is taking place.) It also helps explain her support for the reelection of President Obama, a pro-abortion extremist of epic proportions. (Sr. Campbell, while attending the Democratic National Convention, opined that President

Obama is "not in favor of abortion," saying that she had "never seen him act in that way.")

Responding to the pro-life demonstration in an interview with the Mercyhurst student newspaper, Sr. Campbell asserted that she and the pro-life demonstrators were in full agreement about abortion. That is *not* the case.

Deliberately depriving another human being of his or her life is the gravest of injustices. As Pope Francis reiterated on April 11, 2014, "Life, once conceived, must be protected with the utmost care; abortion and infanticide are abominable crimes."

Only by enacting and enforcing just laws can the government effectively provide the necessary protection. For our nation to willfully withhold this protection from the most innocent and defenseless members of the human family is a grave crime in itself.

The only remedy for the crime of abortion that Sr. Campbell proposes is more government spending on social-welfare programs. But the crux of the matter is legal protection for the unborn, not the size of the federal government. Legal protection of justice for the unborn is indispensable.

Sr. Campbell's approach, like that of a number of similarly-partisan religious figures, ignores legal protection, is at best indifferent to government-funding of abortion-killing, and obviously has no problem with running political cover for even the most aggressively pro-abortion politicians.

### Erie March for Life 2014

Despite the severe winter, we were blessed with remarkably good weather for each of our three January pro-life events this year. The temperature was well above freezing and the winds were calm as two hundred people, including scores of young people, took part in the Erie March for Life on January 11. This year's theme was, "All human rights begin with Life!" Gannon Students for Life led the March carrying the Erie March for Life banner. Rev. Rick Plucknet of the Federated Church and Fr. Mike Polinek of St. George Church led the marchers in prayer and shared some encouraging words at the conclusion of the March. Thanks to all of our marchers!

### 36th Pro-Life Breakfast

Five hundred people attended the 36th annual Pro-Life Breakfast on January 18 at the Bayfront Convention Center. We were honored to host so many dedicated members of the pro-life community and many distinguished pro-life leaders, including: our main speaker Dr. Angela Franks and her mother Dr. Wanda Franz, a past-president of the National Right to Life Committee; PA Pro-Life Federation Executive Director Michael Ciccocioppo; Catholic Bishops Lawrence Persico and Donald Trautman; Congressmen Glenn Thompson and Mike Kelly; State Reps. Michele Brooks and Brad Roae and a number of other government officials and religious leaders.

Prayers were led by Rev. Donald Valasek, pastor of Saint Nicholas Orthodox Church, Rev. Scott Jabo, president of Cathedral Prep and Villa Maria Academy; and Rev. Clifford Hamilton, pastor of East Erie Assembly of God. Saving Simon, a new band of young singers and musicians from Hermitage, Pennsylvania, made the morning extra-special by sharing their passion for the pro-life cause as well as their great music.

## PA Pro-Life PAC endorsements

The Pennsylvania Pro-Life Federation PAC has endorsed Gov. Tom Corbett (R) and Lt. Gov. Jim Cawley (R) for reelection. In legislative races of local interest, the PPLF PAC has endorsed state Rep. Curt Sonney (R-District 4) and state Rep. Brad Roae (R-District 6)

## Governor

Gov. Tom Corbett is the only pro-life candidate in the Pennsylvania gubernatorial primary.

During his first term, Corbett put his pro-life convictions into action in several important ways: He took swift action in response to the Kermit Gosnell scandal. Gosnell is now in prison for murdering newborn infants in his Philadelphia abortion mill. Pennsylvania had, for years, ignored a steady stream of complaints about Gosnell's mistreatment of his female patients. Eleven state employees resigned or were fired outright in the wake of the scandal. Corbett ordered annual inspections and instituted numerous changes at the Pennsylvania

Departments of Health and State to ensure proper monitoring of abortion facilities and quick action when deficiencies are identified. He then signed SB 732, a measure which requires abortion facilities to meet the same standards for patient safety as apply to ambulatory surgery centers. At least six abortion facilities have chosen to shut down rather than address their safety deficiencies. Corbett also signed HB 818, a bill to prohibit Obamacare-funded insurance plans from paying for elective abortions within the Commonwealth.

Planned Parenthood says it will spend \$18 million in 2014 to defeat pro-life candidates in at least 14 states. Gov. Tom Corbett, not surprisingly, is one of the candidates in their crosshairs.

Four candidates are vying for the Democratic nomination for governor. The entire field is pro-abortion. However, the hands down favorite of the abortion industry in Allyson Schwartz. The abortion giant Planned Parenthood picked her out of a crowded field of anti-life candidates and endorsed her in February.

Schwartz was the founder and director, from 1975 to 1988, of a Planned Parenthood abortion facility in Philadelphia. Cecile Richards, the president of Planned Parenthood, put it this way in an April fundraising letter: "Some people just talk the talk but my friend Allyson is the real deal. She opened one of the first women's health care centers in Pennsylvania, just after the law had changed with *Roe v. Wade*. Accomplishing such a bold vision at that point in our country's history took a lot of courage, but Allyson rolled up her sleeves and got the [baby-killing] job done."

## Congress

Incumbent U.S. Reps. Mike Kelly (3rd District) and Glenn Thompson (5th District) are running unopposed in the Republican primary, but both will face Democratic opponents in the fall. Both congressmen have perfect voting records on human life issues: perfect zeroes from NARAL Pro-Choice America and Planned Parenthood and perfect 100% ratings from National Right to Life. The two congressmen attended our 2013 and 2014 Pro-Life Breakfasts, and both spoke eloquently about their pro-life convictions on each occasion.

## State Senate

Three pro-life Republicans and one Democrat (position unknown) are seeking the District 50 state Senate seat, which will be open due to the retirement of pro-life state Sen. Bob Robbins. Two of the Republicans are currently serving in the state House of Representatives: Michele Brooks (District 17) and Greg Lucas (District 5).

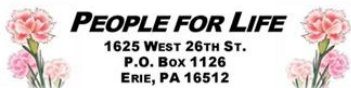
Brooks has represented the 17th Legislative District since 2007 and has attended several of our Pro-Life Breakfasts, most recently this past January. She was a

### State Senate

strong supporter of HB 1077 the *Women's Right to Know Act*, along with state Rep. Brad Roae (District 6).

HB 1077 would have ensured that women preparing to get an abortion would have the option of seeing the sonograms that are routinely taken before practically all surgical and drug-induced abortion procedures.

### State House

Seven candidates are in the race for state representative in Pennsylvania Legislative District 17, and at least four of them have pro-life positions. This district has an open seat because Michele Brooks, the current representative, has decided to run for the District 50 state Senate

seat instead of her current House seat.

One of the pro-life candidates is Republican Ed Franz. Franz has been active with People for Life and Crawford County Citizens for Life for many years. He and his wife Patti conduct our Mother's Day Carnation Project each year at their church in Linesville. Franz also participated in the pro-life demonstration this past March at Mercyhurst University.

winter snow storm. However, the fast-moving storm was expected to be out of the DC area by 10 p.m., even before we left Erie. Bright sunshine, moderate and diminishing winds, and a 0% chance of precipitation was forecast for January 22, the day of the March.

Our buses left Erie right on schedule, and sure enough, we had exceptionally smooth sailing all the way to Washington. We reached our parking area around 6:30 a.m., well ahead of schedule.

The day was indeed sunny and dry with just a light breeze. The temperatures were exceptionally cold for Washington, but they did not interfere with the March or the marchers' high spirits. Approximately 145 people traveled to the March with People for Life this year.
